We have, as yet been unable to reach an agreement for the purchase of the Union Pacific Railroad land in Monroe County, Iowa, between milepost 315.1 and 322.9, known as the southern segment of the Oskaloosa Subdivision.

We are requesting additional time in which to pursue this acquisition and would be pleased if you would grant an additional 6 months in which to complete these negotiations.
