Pursuant to 49 U S C Section 10502, the Surface Transportation Board allowed the Boston and Maine Corporation's and Springfield Terminal Railway Company's Notice of Exemption to abandon and discontinue service over a line of railroad known as the Concord and Claremont Branch in Concord, New Hampshire, extending from railroad milepost 0 9 to milepost 1 86 in Merrimack County by decision dated February 22, 2008, and effective February 26 2008

There being no regulatory barriers to the consummation of this abandonment and discontinuance, the Boston & Maine Corporation and the Springfield Terminal Railway Company hereby give notice pursuant to 49 C F R Section 1152 29(e)(2) that it has exercised the authority granted and fully abandoned and discontinued service on the line as of April 8, 2008 by discontinuing operations on the line with the intent that the property be removed from the interstate rail network


