RE: Proposed Abandonment of the Litchfield Industrial Lead, from Milepost 889.34 to Milepost 892.25; STB Docket No. AB-33 (Sub-No. 266X)

Dear Ms Quinlan

Union Pacific Railroad Company ("UP") has received a request from the City of Goodyear, Arizona (the "City") requesting a Public Use Condition and the issuance of a Certificate or Notice of Interim Trail Use for UP's Litchfield Industrial Lead (the "Line"), which is the subject of the above-referenced matter. A copy of the City's request is attached to this letter.

UP is not willing to negotiate with the City regarding possible trail use. As UP stated in its Petition for Exemption, filed May 28, 2008, the Line runs through an agricultural and industrial area, making trail use impractical. The Line also abuts the eastern perimeter of the Phoenix Goodyear Airport. One potential purchaser has already expressed interest in acquiring a portion of the Line's right-of-way, and UP expects that additional parties will seek to acquire segments of the Line.

The City also asks the Board to impose a public use condition on the Line. While UP will negotiate with the City for a period of 180 days if required to do so by the Board, UP does not believe the Line is suitable for public use. The region is well served by other railroads, highways, energy transmission lines, and other public infrastructure. Moreover, the City does not establish the public importance of its requested public use condition. The only specific public use for the Line that the City proposes is trail use which, as explained above, is not practical.

Dear Ms. Quinlan:

This comment should be treated as a protest or a petition for reconsideration in the above-captioned proceeding. This comment is filed on behalf of the City of Goodyear which is a government agency interested in the use of the abandoned railway for recreational purposes, which is hereinafter referred to as 'Commenter'.

While not taking a position on the merits of this abandonment, Commenter requests issuance of a Public Use Condition as well as a Certificate or Notice of Interim Trail Use rather than an outright abandonment authorization between Milepost 889.34 (Litchfield Junction) and Milepost 892.25 (Litchfield Park).

A. Public Use Condition

Commenter requests the STB to find that this property is suitable for other public use, specifically trail use, and to place the following conditions on the abandonment:

1. An order prohibiting the carrier from disposing of the corridor, other than the tracks, ties and signal equipment, except of -public use on reasonable terms. The justification for this condition is that the corridor would be used for recreational trails and conversion of the property to trail use is in accordance with local plans. In addition, the

corridor provides an important habitat for local wildlife and its preservation as a recreational trail is consistent with that purpose. The time period sought is 180 days from the effective date of the abandonment authorization. Commenter needs this much time - because we have not had an opportunity to gather and review title information, complete a trail plan or begin negotiations with the carrier.

2. An order barring removal or destruction of potential trail-related structures such as bridges, trestles, culverts and tunnels. The justification for this condition is that these structures have considerable value for recreational trail purposes. The time period - requested is 180 days from the effective date of the abandonment authorization for the same reason as indicated above.

B. Interim Trail Use

The railroad right-of-way in this proceeding is suitable for railbanking. In addition to the public use conditions sought above, Commenter also makes the following request:

STATEMENT OF WILLINGNESS TO ASSUME FINANCIAL RESPONSIBILITY


In order to establish interim trail use and rail banking under section 8(d) of the National Trails System Act, 16 U.S.C. §1247(d), and 49 C.F.R. §1152.29, City of Goodyear is willing to assume full responsibility for management of, for any legal liability arising out of the transfer or use of (unless the user is immune from liability, in which case it need only indemnify the railroad against any potential liability), and for the payment of any and all taxes that may be levied or assessed against the right-of-way owned by Union Pacific.

The property, known as the Litchfield Industrial Lead extends from railroad milepost 889.34 near Litchfield Junction to railroad milepost 892.25 near Litchfield Park, a distance of 2.91 miles in Maricopa County, AZ. The right-of-way is part of a line of railroad proposed for abandonment in STB Docket No. AB-33 (Sub-no. 266x).

City of Goodyear acknowledges that use of the right-of-way is subject to the user's continuing to meet its responsibilities described above and subject to possible future reconstruction and reactivation of the right-of-way for rail service.


