

Dear Secretary Quinlan:

On April 3, 2009, Florida Department of Transportation ("FDOT") filed a Verified Notice of Exemption and an accompanying Motion to Dismiss (with separate Appendix) in the above-captioned proceeding. FDOT indicated that CSX Transportation, Inc. ("CSXT") was in the process of contacting shippers on the CSXT rail line which is the subject of this proceeding, and that FDOT would be serving all three pleadings on those shippers.


Dear A-Line Shipper:

Recently you were contacted by a representative of CSX Transportation, Inc. ("CSXT") regarding the proposed sale of CSXT's A-Line between DeLand and Poinciana, Florida to the Florida Department of Transportation ("FDOT"). CSXT will retain a permanent freight operating easement and continue to provide all common carrier freight service on the line.

Enclosed for your information is the notice of exemption and related motion to dismiss filed by FDOT in Finance Docket No. 35110 at the U.S. Surface Transportation Board regarding the proposed transaction.
