**AMENDMENT NO. 7**  
**to the**  
**TTX COMPANY FORM BX CAR CONTRACT**  
**(Effective December 1 through December 31, 2002)**

Pursuant to the authority delegated by the TTX Board of Directors, this Amendment No. 7 to the Form BX Car Contract sets forth temporary car hire charges for use of the Company's RBOX and ABOX cars. The Form BX Car Contract is hereby amended to reflect a temporary car hire rate reduction. This rate reduction will expire on December 31, 2002, at which time the rates will revert to their previous levels.
