Dear Secretary Williams:

This letter is to notify the Board that Delaware and Hudson Railway Company, Inc. has consummated the above-referenced abandonment and has severed the line, discontinued operations, and has removed this trackage from the interstate rail network as of this date. The line for which abandonment has been consummated is the 1.3 +/- mile portion of line in Albany County, New York between Milepost T1.81 +/- and Milepost T3.11 +/-, which traverses through United States Postal Zip Codes 12047 and 12183. The line is one portion of line known as the Troy Branch.

This notice is being served pursuant to 49 C.F.R. parts 1152.29(e)(2) and 1152.50(e) upon the New York Public Service Commission. Accordingly, also enclosed is a certificate of service.
