

UNOPPOSED MOTION FOR FURTHER EXTENSION OF TIME

The Brotherhood of Locomotive Engineers and Trainmen previously requested and the Board granted an extension of the time to April 7, 2006, within which to respond to the Motion for Summary Judgment filed by the BNSF Railway Company. The reason for that extension was so the parties could continue discussions whether the dispute between them can be settled and whether intervening events have made further litigation unnecessary.

The parties are still engaged in such discussions and due to conflicting schedules of the principals need additional time to determine whether they can conclude a settlement. For this reason, and with the consent of the carrier, BLET requests a further extension to May 8 to file a response to BNSF's Motion for Summary Judgment. Again, BNSF consents to the granting of this Motion.


