



STATEMENT OF WILLINGNESS TO ASSUME FINANCIAL RESPONSIBILITY BY
COUNTY OF SAWYER WISCONSIN
PURSUANT TO 49 CFR 1152.29


In order to establish interim trail use and rail banking under 16 USC 1247(d) and 49 CFR 1152.29, the County of Sawyer Wisconsin (CSW) is willing to assume full responsibility for management of, for any legal liability arising out of the transfer or use of (unless the user is immune from liability, in which case it need only indemnify the railroad against any potential liability), and for the payment of any and all taxes that may be levied or assessed against the right-of-way owned by the Wisconsin Central Ltd. (WCL), and operated by Wisconsin Central Ltd.. The property for which CSW is making this Statement of Willingness the line of railroad that extends from railroad milepost 100.80 to railroad milepost 102.60, a distance of 1.80 miles in Hayward and the Town of Hayward, Sawyer County, Wisconsin. The right-of-way is part of a line of railroad proposed for abandonment in Docket No. STB AB-303 (Sub-No. 31X).

A map depicting the property depicting the right-of-way is attached as **Exhibit 1**.

CSW acknowledges that use of the right-of-way is subject to the user's continuing to meet its responsibilities described above and subject to possible future reconstruction and reactivation of the right-of-way for rail service. A copy of this statement is being served on the railroad, Wisconsin Central Ltd., on the same date it is being served on the Board.
