

REQUEST FOR EXPEDITED CONSIDERATION

1. Petitioners, Victor Wheeler and Sandra J. Wheeler; James K. Sisson and Nancy A. Sisson, Bruce D Redfield III, and Tamara J. Redfield; and David A. Warner and Tina M. Warner, adult residents of the state of Pennsylvania, respectfully request the Surface Transportation Board ("Board"), for Expedited Consideration in Docket Nos. FD-35082, and AB-88 (SUB NO. 5X), that all named parties have petitioned the Board to consider concurrently.

2. Victor Wheeler, and the other parties joining in these actions as Petitioners and Respondents, respectively, are owners of land over which the Northwest Pennsylvania Trail Association ("NPTA"), and Material Recovery of Erie, Inc., ("Materials"), are currently constructing and promoting an alleged trail. Until such time as this matter is resolved before the Board and before the United States District Court of the Western District of Pennsylvania, which referred this matter to the Board, the ownership of, liability for, and responsibility for this land will remain unresolved and in dispute.

3. NPTA and Materials have chosen to go forward with their activities on the land in question despite the Federal Court's refusal to dismiss the action against them, effectively ruling that Victor Wheeler, et al., have stated a valid claim for enforcement of the outstanding

STB Order that NPTA and Materials are alleged to have violated. The activities of NPTA and Materials have resulted into a disruption of the peace in the neighborhood. The ownership of the land is clouded until such time as the Board acts on this matter, and the legal uncertainty threatens to give rise to additional actions.

4. A final resolution of the matter may require the District Court to again address the case on appeal subsequent to the decision of the Board. This will result in a further delay for all parties and the likelihood of greater damages and disruption.


CONCLUSION
