


NOTICE OF CONSUMMATION

Pursuant to 49 U.S.C. Section 10502, the Surface Transportation Board allowed the Portland Terminal Company's and Springfield Terminal Railway Company's Notice of Exemption to abandon and discontinue service over a line of railroad known as the Mountain Branch in Westbrook, Maine, extending from railroad milepost 6 0 to milepost 7.3 in Cumberland County by decision dated December 14, 2007 and effective December 18, 2007

There being no regulatory barriers to the consummation of this abandonment and discontinuance, the Portland Terminal Company and the Springfield Terminal Railway Company hereby give notice pursuant to 49 C.F.R. Section 1152.29(e)(2) that it has exercised the authority granted and fully abandoned and discontinued service on the line as of April 16, 2008 by discontinuing operations on the line with the intent that the property be removed from the interstate rail network
