Dear Ms. Brown:

On behalf of the City of Redmond, Washington, King County, Washington and GNP Railway, Inc., I write to request a 20 day extension of the public comment and reply deadlines in the above-captioned docket.

By Notice served on September 15, 2010¹ the Board solicited comments on GNP Rly, Inc.'s petition for exemption from the provisions of 49 U.S.C. § 10902 to acquire and resume rail service over two segments of railbanked right of way in King County, Washington. The notice directed that comments be submitted by October 20, 2010, and replies by November 19, 2010.

The City of Redmond initiated discovery to secure information material to the issues framed by GNP's petition and the Board's notice. The short continuance requested here would enable the orderly completion of this discovery while accommodating the schedule constraints of witnesses and counsel.
