

ERRATA TO UNION PACIFIC'S REPLY EVIDENCE AND ARGUMENT

In the course of addressing a question from Entergy regarding the workpapers submitted with UP's Reply Evidence and Argument, UP determined that portions of its filing erroneously included evidence that was developed using UP's Train Performance Simulator ("TPS") rather than the RTC model. This error affected the calculations of transit time, fuel consumption, and track curvature that are discussed on pages 59-60 of the Reply Evidence and Argument and on pages 8-11 of the Verified Statement of Robert J. Plum and Deborah G. Newland.

To correct its error, UP is submitting calculations of the same measures developed using the RTC model. The RTC model produces essentially the same results as UP's TPS, as shown in the tables below.


