

**MEMORANDUM OF TRUST INDENTURE AND SECURITY AGREEMENT
(BN 1995-F)**

Memorandum of Trust Indenture and Security Agreement, made and entered into as of June 29, 1995 by and between Wilmington Trust Company, as Owner Trustee, a Delaware banking corporation ("*Owner Trustee*"), and First Security Bank of Utah, National Association, as Indenture Trustee, a national banking association ("*Indenture Trustee*").


