NOTICE OF FULL TERMINATION OF LEASE


The undersigned, GATX Corporation, as successor to Pitney Bowes Credit Corporation, as Lessor, publishes this notice that Lease Schedules No. 805, No. 808, No. 810, No. 812 and No. 813 pursuant to Master Equipment Lease Agreement No. 1801174 dated April 24, 1992 (the "Lease"), between the Lessor and ConAgra, Inc., Lessee, has been fully terminated as to all railcars covered therein except with respect to those obligations, if any, of Lessor and Lessee under the Lease which expressly survive any termination thereof.


