MEMORANDUM OF TERMINATION OF LEASE

THIS MEMORANDUM OF TERMINATION OF LEASE (this "Termination") is made as of September 30, 2016, by Greenbrier Leasing Company LLC (the "Current Lessor"), as assignee of WL Ross-Greenbrier Rail I LLC (the "Original Lessor").

1. Original Lessor, as lessor, and CSX Transportation, Inc. ("Lessee"), as lessee, entered into a Lease Agreement dated as of December 14, 2012, effective as of April 29, 2010 (the "Lease Agreement").
2. Original Lessor and Lessee entered into a Schedule No. 1 to the Lease Agreement dated as of January 1, 2013, effective April 29, 2010 (as amended to date, the "Schedule"), covering the one hundred ninety-one (191) 4,480 CF capacity aluminum BethGon II Coal Porter, 286,000 lbs. GRL railcars marked and numbered as set forth in the attached Rail Equipment List (the "Cars").
3. To evidence the above described lease of the Cars by Original Lessor to Lessee (the "Lease"), a Memorandum of Lease Agreement was filed at the Surface Transportation Board on June 7, 2013, under recordation number 30756 (the "Memorandum of Lease").
4. The Lease was assigned by Original Lessor to Current Lessor effective as of September 30, 2015, and a Memorandum of Assignment evidencing such assignment was filed at the Surface Transportation Board on October 7, 2015, under recordation number 30756-A.
5. The Lease has terminated, and Current Lessor is filing this Termination to show for the public record that the Lease has terminated.

IN WITNESS WHEREOF, Current Lessor has caused this Termination to be duly executed by its duly authorized officer as of the date and year first above written, and the undersigned declares under penalty of perjury that he or she holds the title indicated below and that the execution of this Termination of Lease was the free act and deed of the company.
