**TERMINATION OF EQUIPMENT TRUST AGREEMENT (No. 45-B)
(STB)**

THIS TERMINATION OF EQUIPMENT TRUST AGREEMENT (No. 45-B) is made and entered into as of July 5, 2016 by and between WILMINGTON TRUST, NATIONAL ASSOCIATION (as successor to FMB Trust Company, National Association), not in its individual capacity but solely as trustee of TTX Lease 45-B Trust ("*Owner Trustee*"), and WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION (as successor to First Security Bank, National Association), as security trustee ("*Security Trustee*").

1. The Owner Trustee has entered into that certain Lease of Railroad Equipment (No. 45-B) with TTX Company, dated as of September 1, 1997 (as amended, modified or supplemented, the "*Lease*"), a copy of which (or evidence thereof) was filed with the Surface Transportation Board pursuant to the provisions of 49 U.S.C. Section 11301 on September 29, 1997 under Recordation Number 20890, and a copy (or evidence) of Lease Supplement No. 1 (No. 45-B) thereto, dated September 29, 1997, was filed under Recordation Number 20890-A, each with respect to the railroad equipment set forth on Exhibit A attached hereto. The Lease was assigned to the Security Trustee by virtue of an Equipment Trust Agreement (No. 45-B) dated as of September 1, 1997 (as amended, modified or supplemented, the "*Equipment Trust Agreement*"), a copy of which (or evidence thereof) was filed with the Surface Transportation Board pursuant to the provisions of 49 U.S.C. Section 11301 on September 29, 1997 under Recordation Number 20890-C.

2. The Equipment Trust Agreement is terminated effective as of the date hereof solely with respect to, and the Security Trustee hereby releases all of its right, title and interest in and to, the railroad equipment set forth on Exhibit A attached hereto.






