MEMORANDUM OF TERMINATION OF LEASE

The CIT Group/Equipment Financing, Inc. ("CIT") is the lessor, as assignee of NorRail, Inc., under that certain Master Railcar Service and Lease Agreement No. 1749 dated as of September 30, 1997 and Schedule No. 3 thereto (the "Lease"), between NorRail, Inc. and Cereal Food Processors, Inc. ("Lessee"), with respect to the lease to Lessee of certain pressure differential covered hopper cars identified in the Lease.
