

**TERMINATION AND RELEASE OF SECURITY INTEREST**

This TERMINATION AND RELEASE OF SECURITY INTEREST (this "Termination and Release"), dated as of January 4, 2016, is entered into by THRIVENT FINANCIAL FOR LUTHERANS, formerly known as AID ASSOCIATION FOR LUTHERANS, ("Thrivent"), to hereby release all of its right, title and interest in and to the railroad equipment described on Exhibit A hereto.

WHEREAS, Thrivent is party to that certain Assignment of Lease and Rents, dated as of January 15, 1996, from Wells Fargo Bank Northwest, N.A., successor in interest to ATEL LEASING CORPORATION, not in its individual capacity but as Trustee under that certain Trust Agreement dated December 29, 1995 (sometimes referred to as the Mobil Oil Corporation Trust 96-1) ("Owner Trustee"), as Assignor, to Thrivent, as Assignee, filed with the Interstate Commerce Commission (the "Commission") on January 23, 1996 under Recordation Number 19906-B;

WHEREAS, Thrivent, as Secured Party, is party to that certain Memorandum of Security Agreement, dated as of January 15, 1996, between Thrivent, as Secured Party, and Owner Trustee, as Debtor, filed with the Commission on January 23, 1996 under Recordation Number 19906-A; and

WHEREAS, Thrivent now desires to release, terminate and cancel its right, title and security interest in the collateral as described in the foregoing instruments solely with respect to the railroad equipment described on Exhibit A attached hereto.

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned hereby acknowledges the termination and release of its security interest in the collateral as described in the foregoing instruments solely with respect to the railroad equipment described on Exhibit A attached hereto; provided, however, that all provisions of such instruments which by their terms survive termination shall survive and not be deemed terminated or satisfied but shall remain in full force and effect.



