A Progress Payment Agreement dated as of July 20, 2015 was entered by Banc of America Leasing & Capital, LLC ("BALC"), as secured party, and Charah, Inc. ("Charah"), as debtor, for two C30-7 locomotives numbered CLCX 7025 and 7028 (formerly numbered NERR 7025 and 7028, respectively) (the "Locomotives").

A Memorandum of Security Agreement dated as of July 23, 2015 (together with the Progress Payment Agreement, collectively referred to as the "Agreement") between BALC and Charah was recorded at the Surface Transportation Board (the "Board") on July 27, 2015 at 2:43 pm under Recordation No. 31833 for the Locomotives.

For value received, BALC terminates and releases any and all of its rights with respect to the Locomotives under the Agreement, including without limitation any security interests in the Locomotives under the Agreement.
