

**AMENDMENT NO. 1 TO  
MEMORANDUM OF LEASE, SCHEDULE NO. 1**

This Amendment No. 1 to Memorandum of Lease is entered into effective September 1, 2014, and amends that certain Memorandum of Lease for Schedule No. 1 dated March 5, 2008, and effective September 1, 2006, as previously amended (the "Schedule"), to a Lease Agreement made and entered into as of March 5, 2008, and effective September 1, 2006, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor") and Flakeboard Company Limited ("Lessee") (the "Lease Memorandum").

WHEREAS, Lessor and Lessee executed the Lease Memorandum describing the lease by Lessee of thirty-five (35) used 60-foot Plate F boxcars with double eight-foot plug doors, 286,000 GRL, bearing marks and numbers AOK 112206 through AOK 119096 (non inclusive) and CRLE 19315 from Lessor pursuant to the Agreement and the Schedule;

WHEREAS, Lessor and Lessee wish to amend the Lease Memorandum to remove fourteen (14) of the boxcars and to add twenty-three (23) boxcars and to reflect the fact that all of the railcars currently subject to the Schedule are Plat F.

NOW THEREFORE, Lessor and Lessee hereby amend the Lease Memorandum as follows:

1. Exhibit A to the Lease Memorandum is hereby replaced with the Exhibit A attached hereto, reflecting the forty-four (44) Plate G boxcars subject to the Schedule;
2. All other terms and conditions of the Lease Memorandum not specifically amended hereby shall remain in full force and effect.


