

**TERMINATION OF TRUST INDENTURE AND SECURITY AGREEMENT
(1995-2)**

THIS TERMINATION OF TRUST INDENTURE AND SECURITY AGREEMENT (1995-2) is made and entered into as of July 1, 2016, by and between Wells Fargo Bank Northwest, N.A. (as successor in interest to First Security Bank of Utah, National Association), not in its individual capacity, but solely as Owner Trustee ("*Owner Trustee*") and The Bank of New York Mellon Trust Company, N.A. (as successor in interest to Harris Trust and Savings Bank), as Indenture Trustee ("*Indenture Trustee*").

1. The Owner Trustee and Indenture Trustee have heretofore entered into that certain:

a. Trust Indenture and Security Agreement (1995-2), dated as of September 15, 1995 (as amended, supplemented or modified to date, the "*Indenture*"), which was recorded with the Surface Transportation Board on September 29, 1995, under recordation number 19624-A;

b. Trust Indenture and Security Agreement Supplement No. 1 (1995-2), dated as of September 29, 1995 ("*Indenture Supplement No. 1*"), which was recorded with the Surface Transportation Board on September 29, 1995, under recordation number 19624-C;

c. Trust Indenture and Security Agreement Supplement No. 2 (1995-2), dated as of December 29, 1995 ("*Indenture Supplement No. 2*"), which was recorded with the Surface Transportation Board on December 29, 1995, under recordation number 19624-F;

d. Lease Termination, Release of Lien and Bill of Sale, dated as of August 15, 2003, among Lessee, Owner Trustee and Indenture Trustee (the "*Release*"), which was recorded with the Surface Transportation Board on August 15, 2003, under recordation number 19624-I; and

e. A Memorandum of Partial Lease and Partial Indenture Termination, dated as of January 2, 2015, among Lessee, Owner Trustee and Indenture Trustee (the "*Partial Termination*"), which was recorded with the Surface Transportation Board on January 2, 2015 under recordation number 19624-M.


2. Capitalized terms used herein without definition have the meanings assigned to them in the Indenture.

4. The parties acknowledge said termination and desire to clear the public record by execution and recordation of this Instrument.




