

MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

This MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT (this "**Memorandum of Assignment**") is made and entered into as of November 20, 2015, among **General Electric Capital Corporation** ("**Assignor**") and **CF Equipment Leases, LLC** ("**Assignee**"), with reference to the following:

1. Lease Plan U.S.A., Inc. ("**Lease Plan**") agreed to furnish to Alcoa Inc. ("**Lessee**"), and Lessee agreed to lease (the "**Lease**") from Lease Plan, one PL 15B-4RS locomotive numbered CLCX 5118 (the "**Locomotive**"), which lease was evidenced by a Memorandum of Lease Agreement dated April 22, 2005 and recorded with the Surface Transportation Board on March 6, 2007 as Recordation No. 26839.

2. Lease Plan assigned to Assignor, and Assignor assumed from Lease Plan, all right, title and interest of Lease Plan in, to and under the Lease and the Locomotive, which assignment and assumption was evidenced by that certain Memorandum of Assignment and Assumption Agreement dated as of December 22, 2006 between Lease Plan and Assignor, recorded with the Surface Transportation Board on March 6, 2007 as Recordation No. 26839-A.

3. Pursuant to a Contribution and Assumption Agreement dated as of October 1, 2015 (the "**Assignment**"), Assignor assigned to Assignee, and Assignee assumed from Assignor, all of Assignor's right, title and interest in, to and under the Lease and the Locomotive.

4. This Memorandum of Assignment is being recorded with the Surface Transportation Board pursuant to 49 U.S.C. Section 11301(a) for the purpose of giving record notice and evidence of the Assignment, the Lease and the Locomotive.

5. This Memorandum of Assignment may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Assignment.
