

**MEMORANDUM OF ASSIGNMENT**

This **MEMORANDUM OF ASSIGNMENT** is dated as of May 2014, by and between **COMPASS RAIL VIII CORPORATION**, a California corporation ("**Seller**") and **FIRST UNION RAIL CORPORATION**, a North Carolina corporation ("**Purchaser**").

The parties to this Memorandum hereby acknowledge and confirm the following:

1. Seller, as lessor, has leased certain railroad cars more particularly described in Exhibit A attached hereto (the "**Cars**") pursuant to that certain Master Lease Agreement dated as of August 13, 2009, Schedule No. 1, Schedule No. 2, and Schedule No. 3 thereto (Schedule No. 1, Schedule No. 2, Schedule No. 3 and the Master Lease Agreement as it pertains to Schedule No. 1, Schedule No. 2 and Schedule No. 3, each as amended, modified, extended, supplemented, restated and/or replaced from time to time, the "**Lease**") to Intrepid Potash, Inc.

2. A Memorandum of Lease was filed with the U.S. Surface Transportation Board on October 8, 2010 under recordation number 29499.

3. A Memorandum of Lease was filed with the U.S. Surface Transportation Board on October 8, 2010 under recordation number 29500.
