MEMORANDUM OF PARTIAL TERMINATION OF LEASE

THIS MEMORANDUM OF PARTIAL TERMINATION OF LEASE ("Termination") is made as of Sept. 30, 2015 by WL Ross-Greenbrier Rail I LLC, as ultimate assignee of Babcock & Brown Rail Leasing Co. (the "Lessor").

1. Lessor and Potlatch Land & Lumber LLC, formerly known as Potlatch Forest Products Corporation ("Lessee") entered into a Master Full Service Railcar Lease dated as of April 19, 2007 (the "Lease Agreement");
2. Lessor and Lessee entered into a Schedule No. 01 dated as of April 19, 2007, as amended from time to time, to such Lease Agreement (such Schedule, the "Lease") covering the seventy-five (75) 60' Plate E boxcars with 8' sliding doors marked and numbered as set forth in Exhibit A hereto;
3. To evidence the above described Lease, a Memorandum of Full Service Railcar Lease was filed at the Surface Transportation Board on December 18, 2007 under recordation number 27282, which was subsequently assigned under Assignment and Assumption Agreements filed at the Surface Transportation Board on December 21, 2007 under recordation number 27282-A and on April 29, 2010 under recordation number 27282-B (as assigned, the "Memorandum of Lease");
4. Twenty-five (25) of the railcars subject to the Memorandum of Lease have been returned by Lessee to Lessor and removed from the Lease; and
5. Lessor is filing this Partial Termination to reflect the fact that the lease has been terminated as to the twenty-five (25) railcars ("Terminated Cars") described in Exhibit B hereto and the Terminated Cars have been returned to Lessor.

IN WITNESS WHEREOF, Lessor has caused this Memorandum of Partial Termination to be executed by its duly authorized officer as of the date and year first above written, and the undersigned declares under penalty of perjury that he or she holds the title indicated below and that the execution of this Termination of Lease was the free act and deed of the company.


