

**TERMINATION OF LEASE** SURFACE TRANSPORTATION BOARD

THIS TERMINATION OF LEASE dated as of March 17, 2015, is by GATX RAIL LOCOMOTIVE GROUP, L.L.C. ("GATX"), as lessor.

**WHEREAS**, GATX, as lessor, and PROGRESSIVE RAIL, INC., as lessee, entered (1) a Locomotive Lease Agreement, dated as of June 28, 2004 (the "Lease"), (2) Amendment No. 2 to Locomotive Lease Agreement dated as of March 20, 2007 (the "Amendment"), and (3) a Memorandum of Lease and Lease Amendment dated as of March 21, 2007, evidencing the Lease and Amendment (the "Memorandum" and together with the Lease and the Amendment referred to as the "Lien Documents"), which was recorded at the Surface Transportation Board at 2:41 pm on April 18, 2007 under Recordation No. 26930, for on SD38-2 locomotive numbered PGR 42 (formerly LLPX 2806) (the "Locomotive");


