

[Revolving Credit Agreement]

SURFACE TRANSPORTATION BOARD

A Memorandum for Recordation with the Surface Transportation Board under 49 U.S.C. §11301, dated as of October 15, 2010, as amended from time to time (the "Memorandum"), between Deutsche Bank Trust Company Americas, as collateral agent (the "Initial Collateral Agent") and each of the other signatories below (the "Grantors") was recorded with the Surface Transportation Board on October 26, 2010 under Recordation No. 29516 for railcars and other rolling stock of the Grantors. An Assignment Agreement was filed on March 15, 2012 under Recordation no. 29516-C assigning the Initial Collateral Agent's interest in the Memorandum to Comerica Bank, as collateral agent (the "Collateral Agent").


