

An Assignment and Assumption Agreement dated as of September 3, 2014 between ARL, as transferor, and RCF 2014, as transferee, was recorded at the Board on September 3, 2014 at 2:15 pm under Recordation No. 31365-D for 1,875 cars including the Equipment.

For value received, Credit Agricole Corporate and Investment Bank, as Secured Party, only with respect to the Equipment, terminates and releases any and all rights of the Secured Party with respect to the Equipment, including without limitation any security interests in the Equipment.
