**TERMINATION OF EQUIPMENT TRUST AGREEMENT (No. 43-B)
(STB)**

THIS TERMINATION OF EQUIPMENT TRUST AGREEMENT (No. 43-B) is made and entered into as of January 2, 2015 by and between WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION (successor-in-interest to First Security Bank of Utah, National Association), not in its individual capacity, but solely as Owner Trustee (the "*Owner Trustee*"), and WELLS FARGO BANK, NATIONAL ASSOCIATION (successor-in-interest to First Security Bank of Idaho, National Association), as Security Trustee (the "*Security Trustee*").


1. The Owner Trustee has entered into that certain Lease of Railroad Equipment (No. 43-B) with TTX Company dated as of June 15, 1995 (as amended, modified or supplemented, the "*Lease*"), a copy of which (or evidence thereof) was filed with the Interstate Commerce Commission (predecessor to the Surface Transportation Board) pursuant to the provisions of 49 U.S.C. Section 11303 on June 30, 1995 under Recordation Number 19509. The Lease was assigned to the Security Trustee by virtue of an Equipment Trust Agreement (No. 43-B) dated as of June 15, 1995 (as amended, modified or supplemented, the "*Equipment Trust Agreement*"), a copy of which (or evidence thereof) was filed with the Interstate Commerce Commission pursuant to the provisions of 49 U.S.C. Section 11303 on June 30, 1995 under Recordation Number 19509-B.

2. The Equipment Trust Agreement is terminated effective as of the date hereof and the Security Trustee hereby releases all of its right, title and interest in and to the railroad equipment set forth on Exhibit A attached hereto.




