

MEMORANDUM OF CORRECTED LEASE TERMINATION (“*Memorandum*”), dated as of January 12, 2016, by and between BANC OF AMERICA LEASING & CAPITAL, LLC (“*BALC*”) and GARNET OF MARYLAND, INC. (“*Garnet*”). Capitalized terms used herein which are not defined herein shall have their respective meanings ascribed thereto as set forth in the Memorandum of Lease Termination (defined below).

WHEREAS, BALC and Garnet entered into that certain Memorandum of Lease Termination, dated June 29, 2012 and recorded with the Surface Transportation Board (the “*STB*”) on July 11, 2015 as Recordation number 27394-I (the “*Memorandum of Lease Termination*”) in respect of (a) the Lease Agreement dated as of October 22, 2007 (as amended, modified and/or supplemented from time to time, the “*Master Lease*”) (b) Schedule No. 1 to the Master Lease dated as of February 28, 2008 (“*Schedule No. 1*” such Schedule No. 1 and the Master Lease, to the extent incorporated therein, the “*Lease Agreement No. 1*”), (c) Schedule No. 2 to the Master Lease dated as of March 3, 2008 (“*Schedule No. 2*” such Schedule No. 2 and the Master Lease, to the extent incorporated therein, the “*Lease Agreement No. 2*”), (d) Schedule No. 3 to the Master Lease dated as of March 11, 2008 (“*Schedule No. 3*” such Schedule No. 3 and the Master Lease, to the extent incorporated therein, the “*Lease Agreement No. 3*”) and (e) Schedule No. 4 to the Master Lease dated as of March 18, 2008 (“*Schedule No. 4*” such Schedule No. 4 and the Master Lease, to the extent incorporated therein, the “*Lease Agreement No. 4*” and together with Lease Agreement No. 1, Lease Agreement No. 2 and Lease Agreement No. 3, collectively, the “*Lease*”) with respect to the equipment described on Exhibit A hereto (the “*Equipment*”);

WHEREAS, the Memorandum of Lease Termination incorrectly referenced Lease Agreement No. 3 being duly filed with the STB under Recordation Number 27394-E and should have stated that the Recordation Number as 27394-D;






