

MEMORANDUM OF LEASE AGREEMENT

THIS MEMORANDUM OF LEASE AGREEMENT is made effective as of June 25, 2015, by and between TRINITY CHEMICAL LEASING, L.L.C. ("Lessor") and TRINITY CHEMICAL INDUSTRIES, L.L.C. ("Lessee").

1. Pursuant to Lease Schedule No. 003 dated as of June 25, 2015, to that certain Master Railcar Lease Agreement dated as of January 1, 2015 (collectively, the "**Lease Agreement**"), Lessor agreed to lease to Lessee, and the Lessee agreed to lease from Lessor, the railcars described on Schedule A attached hereto (the "**Railcars**").

The terms of the Lease Agreement are hereby incorporated herein by reference.

3. This Memorandum of Lease Agreement may be executed in duplicate originals and any number of counterparts and by different parties in separate counterparts, each of which shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.


