Amendment to Memorandum of Lease Agreement

This AMENDMENT TO MEMORANDUM OF LEASE AGREEMENT is made and entered into as of February 28, 2014 by and between PNC EQUIPMENT FINANCE, LLC, (successor in interest to National City Commercial Capital Corporation) ("Lessor") and J. R. SIMPLOT COMPANY ("Lessee") with reference to the following:

1. Lessor and Lessee have previously filed a Memorandum of Lease dated as of February 27, 2007 (the "Memorandum") with the Surface Transportation Board at Recordation Number 26672-C with reference to the rail equipment described on Exhibit 1 thereto (the "Equipment") and the parties hereto desire to amend the Memorandum as provided for herein.
2. Lessor has agreed pursuant to Master Railcar Lease Agreement dated November 24, 2010, as amended (the "Lease") to lease to Lessee and Lessee has agreed to lease from Lessor, the Equipment.




