TERMINATION OF LEASE AGREEMENT

THIS TERMINATION OF LEASE AGREEMENT is made and entered into as of November 24, 2015 by WELLS FARGO BANK NORTHWEST, N.A., a national banking association (as successor to First Security Bank, N.A.) not in its individual capacity, but solely as trustee (in such capacity, "Owner Trustee") under the Amended and Restated Trust Agreement (GERSC Trust 98-A) dated as of July 22, 1998 (the "Trust Agreement") and GENERAL ELECTRIC RAILCAR SERVICES, LLC, a Delaware limited liability company ("Lessee").

1. The Owner Trustee and Lessee are party to that certain Amended and Restated Equipment Lease Agreement (GERSC Trust 98-A) dated as of July 22, 1998 (as amended, supplemented or modified to date, the "Lease"), as supplemented by that certain Lease Supplement No. 1 (GERSC Trust 98-A) dated July 27, 1998, by which the Owner Trustee leased to Lessee certain railroad equipment (including, without limitation, the equipment described on Schedule 1). A memorandum of the Lease was duly recorded with the Surface Transportation Board on July 27, 1998 at 1:15 pm under recordation number 21530 and a Memorandum of Lease of Railroad Equipment (GERSC Trust 98-A) was filed with the Registrar General of Canada pursuant to Section 105 of the Canada Transportation Act on July 27, 1998 at 12:30 pm under document key 11019. Capitalized terms used herein without definition have the meanings assigned to them in the Lease.

2. The Lease is terminated effective as of the date hereof.

3. This Termination of Lease Agreement shall neither impair nor terminate the rights and obligations of the parties under the Lease which expressly survive termination.






