MEMORANDUM OF SCHEDULE NO. 1

TO LEASE AGREEMENT

BETWEEN

GREENBRIER LEASING COMPANY LLC ("LESSOR")

AND

PLAINS MARKETING, L.P. ("LESSEE")

Memorandum of Schedule No. 1 dated March 1, 2015 to a Lease Agreement made and entered into as of March 1, 2015 by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor") and Plains Marketing, L.P., a Texas limited partnership ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor one hundred twenty-five (125) new, 28,400 gallon, coiled, insulated, DOT 111A100W1, 286,000 lbs GRL tank railcars, with thermal protection, high-flow PRV and 9/16 inch steel shell bearing marks and numbers GBRX 702600 through GBRX 702724, inclusive.
2. Schedule No. 1 to the Lease Agreement shall be effective as of the date first set forth hereinabove and shall be subject to the lease term, as described in the Lease Agreement and Schedule No. 1, as each may be amended from time to time.


