

MEMORANDUM OF ASSIGNMENT OF LEASE

This Memorandum of Assignment of Lease between BB&T Equipment Finance Corporation (the "Assignee") and MassMutual Asset Finance LLC (the "Assignor") is effective as of September 18, 2015.

1. This instrument relates to that certain Master Rail Car Lease Agreement No. 1392 dated as of October 11, 2004 (the "Lease Agreement") and the related Equipment Schedule No. 007 (the "Schedule" which term shall also include any and all riders, addenda and exhibits attached to the Schedule), between ICX Corporation ("ICX"), as lessor, and Duke Energy Progress, Inc. (f/k/a Carolina Power & Light Company) (d/b/a Progress Energy Carolinas, Inc.), as lessee (the "Lessee"), pursuant to which Assignor leased to Lessee the railcars bearing the following reporting marks and road numbers (the "Equipment"):

114 Johnstown 286K GRL railcars bearing reporting marks and road numbers PGNX 7100-7104, PGNX 6100, PGNX 6106-6112 and PGNX 6114-6214

The Schedule and, to the extent incorporated in the Schedule, the Lease Agreement, are collectively referred to hereinafter as the "Lease".

2. A Memorandum of Lease with respect to the Lease was recorded with the Surface Transportation Board under Recordation Number 25323, and a Memorandum of Supplement to Lease was filed with the Surface Transportation Board under Recordation Number 25323-E.

3. Pursuant to certain agreements dated as of March 24, 2005, ICX assigned its interests in the Equipment and the Lease to Winmark Limited Funding, LLC ("WLF"). As a result of these assignments, WLF acquired all of ICX's right, title, and interest in and to the Equipment and the Lease. A Memorandum of Assignment of Lease with respect to such assignment was recorded with the Surface Transportation Board under Recordation Number 25323-L.

4. Pursuant to certain agreements dated as of December 31, 2014, WLF assigned its interests in the Equipment and the Lease to Assignor. As a result of these assignments, Assignor acquired all of WLF's right, title, and interest in and to the Equipment and the Lease. A Memorandum of Assignment of Lease with respect to such assignment was recorded with the Surface Transportation Board under Recordation Number 25323-Y.

5. Pursuant to certain agreements dated as of September 18, 2015, Assignor assigned its interests in the Equipment and the Lease to Assignee. As a result of these assignments, Assignee has acquired all of Assignor's right, title, and interest in and to the Equipment and the Lease of Assignor.
