

PARTIAL TERMINATION OF SECURITY AGREEMENT

THIS PARTIAL TERMINATION OF SECURITY AGREEMENT ("Termination") is made as of August 26, 2014 by Wells Fargo Bank, National Association (the "Secured Party"), for the benefit of Bob Atnip (the "Debtor").

1. Recitals

- A. Secured Party and Debtor entered into a Security Agreement, dated as of April 1, 1997 (the "Agreement"), pursuant to which the Secured Party acquired a security interest in each and every railroad car of every type, kind, name or description set forth in the Agreement. The Agreement is on file at the Surface Transport under Recordation No. 20689 filed on May 22, 1997 at 10:02 AM.
- B. The lien on the railcars more specifically described as TEIX 58189 and 58146 (the "Units") has been released by the Secured Party and the Secured Party claims no security interest in said Units.

2. Termination of Security Interest.


