MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

BETWEEN

GREENBRIER LEASING COMPANY LLC

AND

MUL RAILCARS LEASING, LLC

FEBRUARY 26, 2016

Memorandum of Assignment and Assumption Agreement (this "Memorandum") made and entered into as of February 26, 2016, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Assignor"), and MUL Railcars Leasing, LLC, a Delaware limited liability company ("Assignee").

W I T N E S S E T H:

1. Assignor, as lessor, leased to CSX Transportation, Inc., as lessee ("Lessee"), one hundred ninety-nine (199) used 42-foot covered gondola coil railcars, 286,000 lbs. GRL bearing reporting marks and numbers AOK 494500 through 494699, inclusive, excluding AOK 494648 (the "Cars"), which have been leased pursuant to that certain Master Full Service Lease Agreement dated as of December 14, 2012 and effective as of April 29, 2010 (the "Lease Agreement"), and that certain Schedule No. 02 effective as of May 1, 2011, as amended by Amendment No. 1 to Lease Schedule No. 02 dated as of January 1, 2013, effective as of April 30, 2012, and by Amendment No. 2 to Lease Schedule No. 02 dated as of June 1, 2013, and effective as of April 30, 2013, and by Amendment No. 3 to Lease Schedule No. 02 effective as of April 30, 2014, and by Amendment No. 4 to Lease Schedule No. 02 effective May 1, 2015 (collectively, the "Schedule" and the Schedule incorporating by reference the terms and conditions of the Lease Agreement, the "Lease").
2. Assignor filed a Memorandum of Lease with the STB with respect to the Lease under recordation number 30757 on June 7, 2013 at 9:30 a.m.
3. Assignor has agreed to sell and assign to Assignee and Assignee has agreed to purchase and assume from Assignor, the Cars and certain interests under the Lease, and this Memorandum is being filed with the STB to reflect such assignment and assumption.
4. This Memorandum may be executed by the parties hereto in any number of counterparts, and all counterparts taken together shall be deemed to constitute one instrument.


