

Memorandum of Railcar Lease Agreement

THIS MEMORANDUM OF RAILCAR LEASE AGREEMENT is made and effective as of September 30, 2015 by and between Wells Fargo Equipment Finance, Inc., a Minnesota corporation ("Lessor") and A. Schulman, Inc., a Delaware corporation ("Lessee"), with reference to the following:


