PARTIAL RELEASE OF SECURITY INTEREST AND PARTIAL
TERMINATION OF LEASES

The undersigned, WELLS FARGO BANK, NATIONAL ASSOCIATION (formerly, WACHOVIA FINANCIAL SERVICES, INC. and, formerly, FIRST UNION COMMERCIAL CORPORATION), Secured Party, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge a security interest held by it insofar as the same encumbers the railroad equipment listed in Appendix I attached hereto. Such security interest was granted pursuant to that certain Memorandum of Railcar Mortgage and Security Agreement B, dated December 30, 1998, in favor of the Secured Party, by MAPLE BLUEBELL LIMITED, Obligor, a memorandum of which was filed with the Surface Transportation Board on December 30, 1998 at 12:35 p.m. under Recordation Number 21914-B. 
