RAILCAR COLLATERAL SCHEDULE TERMINATION

This Railcar Collateral Schedule Termination dated as of September 25<sup>th</sup>, 2015 is between SUNTRUST EQUIPMENT FINANCE & LEASING CORP., as "Secured Party" and TRINITY CHEMICAL LEASING, L.L.C., as "Debtor."

This Railcar Collateral Schedule Termination may be executed in separate counterparts, each of which when so executed and delivered shall be an original for all purposes, but all such counterparts shall constitute but one and the same instrument.


