MEMORANDUM OF MASTER INDENTURE, SERIES 2014-1 SUPPLEMENT
— REPLACEMENT RAILCARS

January 7, 2016

This Memorandum of Master Indenture, Series 2014-1 Supplement — Replacement Railcars (this “Memorandum”) is made and entered into by and between Element Rail Leasing I LLC (“Issuer”) and Wilmington Trust Company, not in its individual capacity, but solely as Indenture Trustee (hereinafter referred to as “Indenture Trustee”), respecting that certain Master Indenture, dated as of April 17, 2014, between Issuer and Indenture Trustee (the “Indenture”) and the Series 2014-1 Supplement to the Master Indenture dated as of April 17, 2014 (the “Indenture Supplement” and together with the Indenture, the “Master Indenture”).

Pursuant to the provisions of the Master Indenture, Issuer and Indenture Trustee hereby affirm and acknowledge that:

1. Issuer issued Equipment Notes pursuant to the Master Indenture and, as security therefor, granted to the Indenture Trustee for the benefit of the Noteholders and other secured parties under the Indenture a first priority security interest in, among other things, all of Issuer’s assets, whether now existing or hereafter created or acquired and wherever located, including all right, title and interest, in, to and under the certain railroad equipment described in the Indenture Supplement and, as reflected by this Memorandum, the replacement railroad equipment bearing reporting marks and road numbers as listed on Exhibit A attached hereto, and, solely as it relates to such railroad equipment, the certain lease listed on Exhibit B attached hereto, and subject to the terms defined in the Master Indenture.

2. Issuer and Indenture Trustee further acknowledge and affirm that this Memorandum is not a summary of the Master Indenture nor a complete recitation of the terms and provisions thereof: Accordingly, Issuer and Indenture Trustee hereby agree that in the event of a conflict between this Memorandum and the provisions of the Master Indenture, the provisions of the Master Indenture shall control.

3. This Memorandum is prepared only for the public record and is being recorded with the Surface Transportation Board pursuant to 49 U.S.C. Section 11301(a).




