**MEMORANDUM OF TRUST INDENTURE SUPPLEMENT NO. 6
(GATX TRUST NO. 2005-1C)
(STB)**

THIS MEMORANDUM OF TRUST INDENTURE SUPPLEMENT NO. 6 (GATX TRUST NO. 2005-1C) dated as of November 25, 2013 of **WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION**, not in its individual capacity but solely as Owner Trustee under the Trust Agreement (“**Owner Trustee**”).

W I T N E S S E T H:

The Owner Trustee and the Indenture Trustee have entered into that certain Trust Indenture and Security Agreement (GATX Trust No. 2005-1C) (as amended, modified and supplemented from time to time, the “**Indenture**”), a memorandum of which was filed with the Surface Transportation Board at 11:48 a.m. on March 23, 2005 and assigned recordation number 25514-B.

The undersigned has entered into that certain Trust Indenture Supplement No. 6 (Trust No. 2005-1C), dated as of November 25, 2013, to provide, among other things, for the grant of a security interest by the Owner Trustee to the Indenture Trustee in (i) certain railroad equipment listed on Exhibit A attached hereto, (ii) the Lease Supplement No. 6 to Equipment Lease Agreement (GATX Trust No. 2005-1C) dated as of November 25, 2013, by and between the Owner Trustee and the Lessee.






