PARTIAL RELEASE

This Release is entered into as of March 8, 2016 between The David J. Joseph Company, a Delaware corporation ("Joseph") and Banc of America Leasing & Capital, LLC, a Delaware limited liability company ("BofA"), and effective as of February 29, 2016.

WHEREAS, Joseph and BofA, as successor-in-interest to LaSalle National Leasing Corporation, are parties to a Purchase and Sale Agreement dated as of February 23, 2006 (the "Agreement") pursuant to which (a) BofA purchased the railroad cars identified on Exhibit A hereto (the "Railcars") and (b) BofA granted Joseph certain rights in such Railcars which operated as a lien upon such Railcars;

WHEREAS, Joseph and BofA memorialized the Agreements of the parties by filing Memorandum of Assignment and Assumption Agreements (collectively, "Memorandum of Assignment and Assumption") with the STB; and

WHEREAS, the Memorandum of Assignment and Assumption was recorded with the STB and assigned recordation number 26244-F.

WHEREAS, Joseph and BofA further memorialized the Agreement of record by filing a Memorandum of Options, Rights of First Refusal and Remarketing Rights between Joseph and BofA (the "Memorandum of Options, Rights of First Refusal and Remarketing Rights") with the Surface Transportation Board (the "STB"); and

WHEREAS, the Memorandum of Options, Rights of First Refusal and Remarketing Rights was recorded with the STB and assigned recordation number 26244-G.

NOW THEREFORE, in consideration of the premises and mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. The Memorandum of Options, Rights of First Refusal and Remarketing Rights as it pertains to Rider No. 1 and Rider No. 2 as defined in Exhibit A of the Memorandum of Options, Rights of First Refusal and Remarketing Rights is hereby terminated. The parties hereby release all rights, interests or claims to, and all liens and encumbrances upon, the Railcars as given under the Memorandum of Options, Rights of First Refusal and Remarketing Rights with regard only to Rider No. 1 and Rider No. 2.

2. The parties desire to execute this Release for purposes of memorializing of record the agreement set forth herein.

IN WITNESS WHEREOF, this Release has been duly executed by the duly authorized officer of Joseph as of the date and year first above written.


