MEMORANDUM OF FULL TERMINATION OF LEASE

This MEMORANDUM OF FULL TERMINATION OF LEASE (the "Memorandum") dated as of October 19, 2015 is made by First Union Rail Corporation (the "Lessor"), a North Carolina corporation, and pertains to that certain Lease Agreement dated as of November 1, 1996 and Schedule No. 1 Description of Equipment dated November 15, 1996, November 19, 1996, December 17, 1996, December 30, 1996, February 4, 1997 and September 30, 1997 (collectively, the "Lease"), between Lessor and Farmer's Commodities Transportation Company, L.L.C. (the "Lessee"), a Delaware limited liability company.

W I T N E S S E T H:

WHEREAS, Lessor and Lessee entered into the Lease whereby Lessor has agreed to lease to Lessee certain railcars (the "Equipment") as more particularly described in on Exhibit A attached hereto; and,

WHEREAS, Lessor and Lessee entered into certain Memoranda of Lease, evidencing the above-described Lease of such Equipment, which were filed at the Surface Transportation Board on January 27, 1997 at 10:32 a.m. with recordation number 20511, and also at 10:40 a.m. on January 27, 1997 with recordation numbers 20510, 20512 and 20513; on October 2, 1997 at 3:37 p.m. with recordation number 20918 and on January 26, 1998 at 11:25 a.m. having recordation number 21175 and,

WHEREAS, Lessor and Lessee also entered into certain Memoranda of Lease, evidencing the above-described Lease of such Equipment, which were deposited with the Registrar General of Canada on January 27, 1997 at 3:26 p.m., 3:27 p.m., 3:28 p.m. and 3:29 p.m., October 7, 1997 at 11:30 a.m. and January 27, 1998 at 3:08 p.m.

WHEREAS, the Equipment has been released and is no longer covered under the Lease; and,

NOW, THEREFORE, the Lessor desires to clarify the public record to state as follows:

1. This Notice serves as notice that the Equipment listed on the attached Exhibit A as evidenced by the Memoranda of Lease filed with the Surface Transportation Board and Registrar General of Canada, have been terminated in all respects.
2. All of the interests of the Lessee, its successors and assigns, in the Equipment listed on Exhibit A arising pursuant to the Lease have been terminated.
3. Lessor wishes to record this Memorandum of Full Termination of Lease so as to release the lien with respect to the Equipment.


