THIS MEMORANDUM OF TERMINATION OF LEASE is intended to evidence the termination of that certain Lease specified on Schedule 1 between RALCO, LLC ("Lessor") and Sam Mannino Enterprises, Inc. of 191 Anaconda Drive, Pennsylvania Furnace, PA 16865 ("Lessee") pursuant to which Lessor has leased to Lessee the railcars specified on Schedule 1 hereto (the "Cars").
