MEMORANDUM OF RAILCAR LEASE

THIS MEMORANDUM OF RAILCAR LEASE dated as of this 26 day of August, 2014, is made by CIT Railcar Funding Company, LLC, a Delaware limited liability company, with an address at 30 South Wacker Drive, Suite 2900, Chicago, Illinois 60606 (the "Lessor"), and Schlumberger Technology Corp., a Texas corporation, with an address at 300 Schlumberger Drive, Sugar Land, Texas, 77478 (the "Lessee" and, together with the Lessor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, the Lessor and the Lessee are parties to that certain Master Net Railcar Lease (the "Agreement") dated as of January 12, 2005. Pursuant to the Agreement, Lessor and Lessee entered into Schedule No. 02 thereto dated as of April 25, 2005 (as previously amended by Amendment No. 01 dated as of April 12, 2010, and effective June 1, 2010, and Amendment No. 02 dated May 6, 2014, the "Schedule"; the Schedule and the Agreement to the extent relating to the Schedule, are hereinafter referred to as the "Lease") covering the equipment listed on Schedule A hereto (the "Equipment"), and
