PARTIAL TERMINATION OF SECURITY AGREEMENT

THIS PARTIAL TERMINATION OF SECURITY AGREEMENT ("Termination") is made as of November 13, 2013 by Wells Fargo Bank Texas, N. A. (the "Secured Party"), for the benefit of Bob Atnlp (the "Debtor").

1. Recitals.

A. Secured Party and Debtor entered into a Commercial Security Agreement dated as of April 1, 1997 (the "Agreement") pursuant to which the Secured Party acquired a security interest in each and every railroad car of every type, kind, name or description then owned by Debtor or thereafter acquired. The Agreement is on file at the Surface Transportation Board under Recordation No. 20689 filed on _____ at _____ AM.

B. The lien on the railcars more specifically described as attached as TEAX 30044, TEIX 30045, TEIX 33526, TEIX 33527 ("Units") has been released by the Secured Party and the Secured Party claims no security interest in said Units.
