MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

BETWEEN

AND

MUL RAILCARS LEASING, LLC

FEBRUARY 20, 2015

Memorandum of Assignment and Assumption Agreement (this "Memorandum") made and entered into as of February 20, 2015, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Assignor"), and MUL Railcars Leasing, LLC, a Delaware limited liability company ("Assignee").

WITNESSETH:

1. Assignor, as lessor, leased to Halliburton Company, as lessee ("Lessee"), two hundred (200) 3,250 cubic foot capacity covered hopper railcars, marked and numbered HWCX 8701- HWCX 8900, inclusive (the "Cars"), pursuant to that certain Lease Agreement made as of June 1, 2014 (the "Lease Agreement"), and that certain Schedule No. 3 thereto dated as of August 25, 2014 ("Schedule No. 3").


