**MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASES**  
(Surface Transportation Board)

THIS MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASES (this "Memorandum") dated as of March 27, 2014, is between MIDWEST RAILCAR CORPORATION ("Assignor") and GREENBRIER LEASING COMPANY LLC ("Assignee").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. Assignor is the lessor under Schedule #4, Schedule #5, Schedule #6, Schedule #7, Schedule #8, Schedule #9, and Schedule #10 (each individually, a "Lease Schedule" and collectively, the "Lease Schedules"), each dated as of December 23, 2013 and each to the Full Service Master Lease Agreement dated as of June 16, 2004 (the "Lease Agreement"), each by and between Assignor, as lessor, and US Silica Company ("Lessee"), as lessee (each Lease Schedule, together with the Lease Agreement solely as it pertains to such Lease Schedule, a "Lease", and collectively, the "Leases"). 




