

**TERMINATION AGREEMENT****SURFACE TRANSPORTATION BOARD**

THIS TERMINATION AGREEMENT (the "Agreement") is made and entered into as of the 22nd day of January, 2014 (the "Effective Date"), by and among UNION TANK CAR COMPANY, a Delaware corporation, as Owner Participant (the "Owner Participant") and as the Company (the "Company"), U.S. BANK NATIONAL ASSOCIATION, a national banking association, successor in interest to Connecticut National Bank, not in its individual capacity, except as expressly set forth herein, but solely as Owner Trustee under each Trust Agreement (the "Trust Agreements") set forth on Exhibit A and Exhibit D hereto (each an "Owner Trustee", collectively the "Owner Trustees"), and THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., a national banking association, as Indenture Trustee (the "Indenture Trustee") and as Pass Through Trustee (the "Pass Through Trustee").

**RECITALS**

WHEREAS, the documents described on Exhibit A (the "Operative Documents") were executed in connection with a leveraged lease financing of the equipment described on Exhibit B hereto (the "Equipment") for the benefit of the Company; and

WHEREAS, the Owner Participant has heretofore acquired all rights and interests of the Original Owner Participants under the Participation Agreements set forth on Exhibit A (the "Participation Agreements"); and

WHEREAS, all notes and other obligations issued under the Indentures and the Pass-Through Agreements set forth on Exhibit A have been paid and satisfied in full; and

WHEREAS, in connection with the sale of the Equipment to the Company, the parties hereto desire to terminate each of the Operative Documents on the terms and conditions set forth herein;

NOW, THEREFORE, in consideration of the mutual promises contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Owner Participant, the Company, each Owner Trustee, the Indenture Trustee and the Pass Through Trustee (collectively, the "Parties") hereby agree as follows:

1. Capitalized Terms. All capitalized terms not otherwise defined in this Agreement shall have the meaning ascribed to them in Exhibit A hereto.

2. Termination of Operative Documents; Conveyance of Equipment. The Parties agree that the Operative Documents shall be terminated and be of no further force or effect upon the Effective Date and the transfer of title to the Equipment to the Company. On the Effective Date, the Owner Trustees (as successors to the Original Terminating Owner Trustees) shall deliver the Bill of Sale, attached hereto as Exhibit C (the "Bill of Sale"), to the Company conveying the Equipment, AS-IS, WHERE-IS, with all faults, to the Company. Thereafter, the Parties (other than the Company) shall have no rights or interest whatsoever in the Equipment. For the avoidance of doubt, other than the Indentures set forth on Exhibit A, the documents relating to Trusts L-7K, L-8K, L-9K and L-10K remain in full force and effect and the equipment relating thereto is not being conveyed under this Agreement or the Bill of Sale.

3. Consideration. In consideration of the termination of the Operative Documents by the Parties hereto, the Company agrees that the indemnification provisions of the Operative Documents, including, but not limited to those set forth in Article VII of each Participation Agreement and Article IX of each Trust Agreement, shall survive the termination of the Operative Documents.

4. Severability. If any one or more of the provisions contained in this Agreement is for any reason held to be invalid or unenforceable in any respect, such invalidity or unenforceability shall not affect any other provisions of this Agreement, and this Agreement shall be construed as if such invalid or unenforceable provision had never been contained herein.

5. Binding Agreement; Authority. All provisions contained in this Agreement shall be binding upon, inure to the benefit of, and be enforceable by, the respective successors and assigns of the parties hereto. The parties hereto represent and warrant to one another that they have taken all necessary corporate actions to authorize the execution of this Agreement and that the individuals signing this Agreement on behalf of such parties are the duly authorized signatories of such parties.

6. Governing Law; Interpretation. This Agreement shall be interpreted under the laws of the State of Illinois. The section and subsection captions hereof are for the convenient reference of the parties only and are not intended to and shall not be deemed to modify the interpretation of the section or subsection from that which is indicated by the text of the section or subsection alone.

7. Merger, Amendment. This Agreement, together with the bill or bills of sale conveying title to the Equipment to the Company, sets forth the entire agreement between the Parties with respect to the subject matter hereof and all prior negotiations or agreements, whether oral or written, are superseded and merged herein. This Agreement may not be altered or amended except by a writing duly authorized and executed by the party against whom enforcement is sought.

8. Counterparts; Facsimile. This Agreement may be executed in multiple counterparts, which together shall constitute one and the same agreement. The signature of either party hereto sent to the other via facsimile shall constitute the valid execution and delivery of this Agreement by such party.

9. Limitation of Liability

It is expressly understood and agreed that (a) this Agreement is executed and delivered by U.S. Bank National Association, not individually or personally but solely as Owner Trustee under each Trust Agreement, (b) any representation, undertaking or agreement herein made on the part of each Owner Trustee is made and intended not as a personal representation, undertaking and agreement by U.S. Bank National Association and (c) under no circumstances shall U.S. Bank National Association be liable in its individual or corporate capacity for the payment of any indebtedness or expenses of any Owner Trustee or be liable for the breach or failure of any obligation, representation, warranty or covenant made or undertaken by any Owner Trustee hereunder.

10. Direction

The Owner Participant hereby: (i) authorizes and directs (a) each Owner Trustee to execute and deliver this Agreement, (b) each Owner Trustee (as successor to each Original Terminating Owner Trustee) to execute and deliver the Bill of Sale and (c) each Owner Trustee to execute and deliver such other documents or agreements in furtherance of the foregoing; and (ii) acknowledges its obligation to indemnify each Owner Trustee in accordance with each Trust Agreement.







## BILL OF SALE

U.S. BANK NATIONAL ASSOCIATION, a national banking association, not in its individual capacity, except as expressly stated herein, but solely as Owner Trustee under each Trust Agreement described below (collectively, the "Owner Trustee") under the following documents, in consideration of the sum of One Dollar (\$1) and other good and valuable consideration paid to it by UNION TANK CAR COMPANY, a Delaware corporation ("Buyer"), at or before the execution and delivery of these presents, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, transfer, convey, assign and set over unto Buyer and its successors and assigns all right, title and interest of the Owner Trustee in and to each unit of railroad equipment, together with appurtenances, accessories, parts and other equipment or property incorporated in, installed on or attached to such unit (collectively, the "Equipment") set forth on Exhibit A hereto:

2. Trust Agreement (L-2N) (UTC Trust No. 1992-A) dated as of June 24, 1992 between NYNEX and CNB.
3. Trust Agreement (L-3N) (UTC Trust No. 1992-A) dated as of June 24, 1992 between NYNEX and CNB.
4. Trust Agreement (L-4N) (UTC Trust No. 1992-A) dated as of June 24, 1992 between NYNEX and CNB.
5. Trust Agreement (L-5U) (UTC Trust No. 1992-A) dated as of June 24, 1992 between Unionbanc Leasing Corporation ("Unionbanc") and CNB.
6. Trust Agreement (L-6U) (UTC Trust No. 1992-A) dated as of June 24, 1992 between Unionbanc and CNB.

The Owner Trustee has succeeded to the rights of CNB and the Buyer has acquired the rights and interest of NYNEX and Unionbanc under each of the Trust Agreements described above.

To have and to hold all and singular the rights to the Equipment to Buyer and its successors and assigns for their own use and behoof forever.

The sale of the Equipment by the Owner Trustee hereunder is "as is" "where is" with all faults, with no representation or warranty of any kind, except that the Owner Trustee hereby warrants to Buyer and its successors and assigns that the Equipment is free and clear of all Lessor's Liens (as defined in the Trust Agreements and the documents relating thereto) attributable to the Owner Trustee.

OWNER TRUSTEE SELLS THE EQUIPMENT IN "AS IS, WHERE IS" CONDITION, WITH ALL FAULTS AND OWNER TRUSTEE MAKES NO REPRESENTATIONS OR

WARRANTIES OF ANY KIND EXCEPT AS EXPRESSLY SET FORTH IN THIS BILL OF SALE INCLUDING, RESPECTING THE CONDITION OF THE EQUIPMENT WHETHER STATUTORY, WRITTEN, ORAL OR IMPLIED, AND SELLER HAS NOT MADE AND DOES NOT HEREBY MAKE, NOR SHALL IT BE DEEMED BY VIRTUE OF HAVING SOLD THE EQUIPMENT PURSUANT TO THIS AGREEMENT TO HAVE MADE, ANY REPRESENTATION OR WARRANTY AS TO THE MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, DESIGN OR CONDITION OF, OR AS TO THE QUALITY OF WORKMANSHIP IN THE EQUIPMENT, ALL OF WHICH ARE EXPRESSLY DISCLAIMED, AND OWNER TRUSTEE SHALL NOT BE LIABLE, FOR ANY CONSEQUENTIAL, INCIDENTAL OR SPECIAL PURPOSE DAMAGES IN CONTRACT, TORT OR OTHERWISE, ON ACCOUNT OF THIS AGREEMENT OR ANY MANUFACTURER'S DEFECT OR OTHER DEFECTS, WHETHER HIDDEN, LATENT OR OTHERWISE DISCOVERABLE OR NONDISCOVERABLE RESPECTING ANY ITEM OF EQUIPMENT.
