MEMORANDUM OF EQUIPMENT LEASE AGREEMENT

This Memorandum of an Equipment Lease Agreement is made and entered into as of March 1, 2010, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, ("Lessor") and KES Acquisition Company, a Delaware corporation, dba Kentucky Electric Steel Co. ("Lessee").

IN WITNESS WHEREOF, the parties hereto have caused this instrument to be signed by their respective officers as of the date and year first above written.






